
Advertisement for faculty posts



(iii) At least 4 years teaching experience as Associate Professor in the concerned specialty failing which an Associate Professor having 7 years teaching experience as Associate Professor and Assistant Professor combined in the concerned specialty. Holders of educational qualifications included in part-II of the third schedule should also fulfill the conditions stipulated in sub-section (3) of section-13 of the Indian Medical Council Act, 1956.

(ii) A postgraduate degree in the concerned specialty (i.e. MD/MS) or its equivalent qualifications.

(iii) At least five years teaching experience as Assistant Professor in the concerned specialty failing which an Assistant Professor having Six years teaching experience as Assistant Professor and Lecturer combined which shall include four years teaching experience as Assistant Professor in the concerned specialty after post graduation in any recognized Medical College. However, in all cases the incumbent should possess atleast five years teaching experience after post graduation in the concerned specialty.

Holders of educational qualification included in part-II of the third schedule should also fulfill the conditions stipulated in sub-section (3) of section-13 of the Indian Medical Council Act, 1956.

(ii) A postgraduate degree in the concerned speciality (i.e. MD/MS) or its equivalent qualifications.

(iii) At least 3 years teaching experience as Lecturer / Registrar / Demonstrator/ Resident after doing post-graduation in the concerned speciality in any recognized Medical College.


