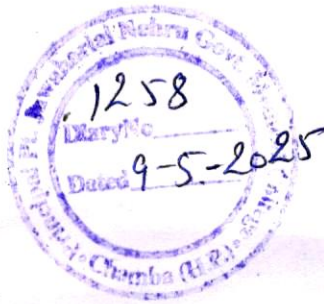



"OFFICE ORDER"

On the basis of recommendations of the Counselling Committee (Sr. Resident/Tutor Specialist) at Pt. JLN GMC, Chamba and as per approval conveyed by the Government vide letter No HFW-B-0015/29/2023-HEALTH-B dated 26.04.2025, the following candidates are hereby appointed as Jr. Residents at Pt. The appointment is further subject to following terms and conditions :-

1. The offer of appointment is ordinarily for a period of one year on tenure basis.
2. The candidates shall give legal undertaking in the form of affidavit with the concerned Principal at the time of joining that he/she shall not claim for regularization /continuation/ promotion /increment and other ancillary benefit against these tenure posts on the completion of their respective tenure. The Principal, concerned shall be the competent authority to ensure that the legal undertaking in the form of affidavit is submitted by the concerned /selected candidates before, their joining.
3. The private practice will not be permissible.
4. No TA/DA will be admissible to join the assignment.
5. The appointee will not be allowed to change the specialty/ department in any case.
6. The candidate appointed as Junior Resident (Direct) will only be entitled for one day casual leave in completed calendar month.
7. GDO appointed on regular basis on their selection as Junior Resident will continue to draw pay and allowance /increments as admissible to them in their pay scale.
8. The Direct candidate (MBBS) who join as Jr. Resident shall be eligible to draw the pay as prescribed for a Jr. Resident which is as under :-

Jr. Resident: Rs. 41,000/- per month

- For GDO candidates, leave will be admissible under CCS leave rule, 1972:
9. Once appointed, the incumbent can be removed from the post any time after joining in case of misconduct, misbehavior, acts of commission/omission, unbecoming of a public servant. The HOD will make a formal request in writing to the Principal of the Medical College for removing the delinquent appointee. The Principal of the Medical College will take final decision in the matter after hearing both the parties. It will be necessary to give due opportunity to the concerned Jr. Resident to explain his/her position. The Principal shall forward his/her recommendations to the Government, and the final decision shall be taken at the level of Government.
10. Similarly, if the performance is not satisfactory as reported by the Head of the department during annual performance appraisals, the Principal shall hear the parties and forward the case to the Government for discontinuation of services, if so required alongwith his/her findings and recommendations.
11. Any Jr. Resident shall have to give one month's notice or salary in lieu thereof to resign and the concerned Principal will accept the same.
12. The Direct candidates are required to submit character certificate issued by the Tehsildar concerned from where candidates belong at the time of joining in the College.
13. The candidate(s) working on regular/ahdoc/contract or in RKS in the State of H.P. shall have to submit his/her relieving orders /letter from respective department at the time of joining failing which his/her joining will not be entertained.
14. The direct candidate is required to get him/her medically examined from Medical Board of concerned Medical Colleges before joining failing which their joining report shall not be entertained by the respective Principal.

15.If the terms and conditions are acceptable, he/she should join the assignment in the department concerned on or before 20.05.2025 , positively failing which this offer of appointment shall stand cancelled automatically and no further correspondence shall be entertained in this behalf.

Note: In addition to above, all the terms and conditions mentioned in the Resident Doctor Policy dated 24.12.2021 as amended from time to time, shall be applicable upon the aforesaid selected candidates.
