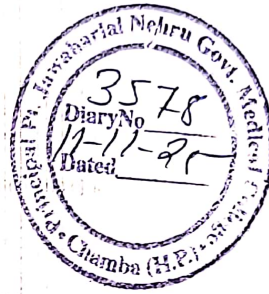

The engagement order is further subject to following terms and conditions:-

1. The offer of engagement is ordinarily for a period of one year on tenure basis. The candidates shall give legal undertaking in the form of affidavit with the concerned Principal at the time of joining that he / she shall not claim for regularization / continuation / promotion / increment and any other ancillary benefit against the tenure post which he/she selected on completion of their normal tenure i.e. one year from the date of joining; and the Principal concerned shall be competent authority to ensure that the legal undertaking in the form of affidavit is submitted by the concerned/selected candidates before their joining.
2. The candidate shall not claim to increase his /her monthly emoluments /allowances/pay on the analogy of other regular Government employees on the Medical Education / Health Department of Himachal Pradesh.
3. The candidate shall not claim that his/her services may be continued. In all case, further extension can be granted on the recommendations of the Principal concerned as well as keeping in view of the larger public interest of patient care and the Govt. will be competent authority for the same.
4. If the Govt. does not grant timely extension despite the recommendations of the concerned Principal, the services of the candidate will automatically terminate from the next day after the completion of his/her normal tenure.
5. The services of the selectee are liable to be terminated by the Government in case the work and conduct /performance of the candidate during the tenure period is not found satisfactory.
6. During the tenure period, no advance will be given to the selectee.
7. Unauthorized willful absence from the duty without approval of the controlling authority i.e. Principal concerned, shall automatically lead to the termination of the services. During the period of unauthorized absence from the duty, the emoluments shall not be paid for the said period of the selectee.
8. The transfer of the candidate/selectee shall not be permitted from one Govt. Medical College/institution to another in any circumstances.

9. The selectee will have submitted a certificate of his/her fitness from the Medical Board of the concerned district. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The Women candidate will be re-examined for the fitness.
10. The Principal concerned shall be competent authority under these term and condition to ensure that the agreement has been signed strictly as per the terms and condition filed by the Govt. for the post of Medical Officer (Specialist) and Medical Officer (Super specialist) and the Director Medical Education & Research shall competent authority to sign the agreement.
11. The Principal concerned shall be competent authority to ensure that the legal undertaking in the form of affidavit is submitted by the concerned /selected candidate before their joining.
12. Provided that the Principal concerned shall be competent authority to ensure that the selectee has submitted correct affidavit as per the terms and conditions fixed by the Government from time to time.
13. The private practice will not be permissible and no TA/DA will be admissible to join the assignment.
14. The appointee will not be allowed to change the specialty /Department in any case.
15. The candidate appointed as Jr. Resident /Tutor General (Direct) will only be entitled for one day casual leave in completed calendar month.
16. GDO appointed on regular basis on their selection as Jr. Resident/Tutor General will continue to draw pay and allowance/increments as admissible to them in their pay scale.
17. The Direct candidate (MBBS) who join as Jr. Resident/Tutor General shall be eligible to draw the pay as prescribed for a Jr. Resident which is as under:-
- Jr. Resident/Tutor General: Rs 41,000/per month.**
18. For GDO candidates, leave will be admissible under CCS leave rule, 1972.

19. Once appointed, the incumbent can be removed from the post any time after joining in case of misconduct, misbehaviour, acts of commission/omission, unbecoming of a public servant. The HOD will make a formal request in writing to the concerned Principal of the institution for removing the delinquent appointee. The concerned Principal of the institution will take final decision in the matter after hearing both the parties. It will be necessary to give due opportunity to the concerned Jr. Resident/ Tutor-General to explain his/her position. The Principal shall forward his/her recommendations to the Government, and the final decision shall be taken at the level of Government.

20. Similarly, if the performance is not satisfactory as reported by the Head of the department during the tenure period, the Principal shall hear the parties and forward the case to the Government for discontinuation of services, if so required along with his/her findings and recommendations.

21. Any Jr. Resident/Tutor - General shall have to give one month's notice or salary in lieu thereof to resign and the concerned Principal will accept the same.

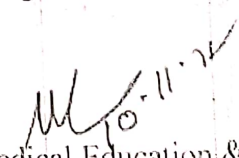
22. The Direct candidates are required to submit character certificate issued by the Tehsildar concerned from where candidates belong at the time of joining in the College.

23. The candidate(s) working on regular/ahdoc/contract or in RKS in the State of H.P. shall have to submit his/her relieving orders/letter from respective department at the time of joining failing which his/her joining will not be entertained.

24. If the terms and conditions are acceptable, he/she should join the assignment in the department concerned/institution on or before 27.11.2025, positively failing which order in r/o non joining candidates stands cancel automatically and no further corresponding in this regard will be made.
